# 2024 Construction Season

You or someone you know need gas hook-up in 2024? Sign up early to get on our construction list to avoid any delays and potential cost increases due to inflation.

Rural Infill Costs - \$8,250.00 Urban Infill Costs - \$4,500.00

#### What to expect in 2024:

- We currently have 30 km of 2" pipe and 10 km of 1" pipe on order. Our goal is to install another 40 km of replacement pipe in 2024.
- Crews will be working in the Sylvan Lake area at Tap 20 and Tap 30 installing 18 km of replacement pipe
- Crews will also be installing Loop Lines in the Crestomere area.

As soon as the ground thaws, we will begin our 2024 construction season, installing new pipe and working on routing gas lines to newly constructed buildings.

# Carbon Tax Increase Effective April 1, 2024

These rates are prescribed by the *Government of Canada* on an increasing scale and are scheduled to increase to \$95 per tonne in April 2025.

April 1, 2024 = \$ 4.10/GJ

Natural Gas Utilities are required to charge these rates as per the *Federal Greenhouse Gas Pollution Pricing Act*.

All fees charged under this Act are remitted directly to Revenue Canada.

The new rate will be automatically applied to your bill for natural gas consumed beginning April 1, 2024.

#### **Nomination Process**

Each member (in good standing) may nominate one candidate (in good standing) to the Board for an available position. If members are not in good standing, they will not have the right to be nominated or vote. Not more than 4 board members can be urban contract holders at the time of nomination. Neither Management nor employees can nominate a candidate, but are eligible to vote. Nomination forms must be signed by the member and nominated candidate.
